possible contain the spill. Place inert absorbent, non-combustible material onto spillage. Use clean non-sparking tools to collect the material and place into suitable labelled containers for the subsequent recycling or disposal. If contamination of sewers or waterways occurs inform the local water authorities and EPA in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling	Wear appropriate protective equipment to prevent inhalation and eye exposure. Use in designated areas with adequate ventilation. Avoid breathing in spray, mist or vapours. Keep containers closed when not in use. Do not use near welding or other ignition sources and avoid sparks. Do not smoke. Practice good personal hygiene, that is, always wash hands after handling, and before eating, drinking, smoking or using the toilet facilities.
Conditions for Safe Storage	Store in a cool, dry well-ventilated area away from heat, sources of ignition, oxidising agents, foodstuffs, and out of direct sunlight. Keep containers closed when not in use and securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Do NOT pressurise, cut, heat or weld containers as they may contain hazardous residues. National Exposure Standards	No exposure standards have been established for this material, however, the TWA National Occupational Health And Safety Commission (NOHSC) exposure standards for oil mist is 5 mg/m ³ . As with all chemicals, exposure should be kept to the lowest possible levels.
Biological Limit Values	TWA - the Time-Weighted Average airborne concentration over an eight-hour working day, for a five-day working week. No biological limit allocated.
Engineering Controls	Provide sufficient ventilation to keep airborne levels below the exposure limit. Where vapours or mists are generated, particularly in enclosed areas, and natural ventilation is inadequate, a local exhaust ventilation system is required. Refer to AS1940 - The storage and handling of flammable and combustible liquids and AS2430 - Explosive gas atmospheres for further information concerning ventilation requirements.
