### 2023 PENRITE BRAND AMBASSADOR PROGRAM - TERMS AND CONDITIONS

### **CONDITIONS OF ENTRY**

Information on how to enter, mechanics of entry and the products that form part of these Conditions of Entry are all located within this set of terms and conditions. Entry into the program is acceptance of these Conditions of Entry. Entry is via Internet only. Entry only provides the applicant with a chance to become a Penrite Brand Ambassador for the 2023 calendar year.

Acceptance is solely up to the promoter, Penrite Oil Company, no further correspondence will be entered into. The applicant gives the promoter all commercial, marketing and legal ownership of the data submitted, including all uploaded images and permits. The promoter (Penrite Oil Company) is to retain ownership over all publication, duplication and amendments to the original data.

# 2023 BRAND AMBASSADOR DETERMINATION / SELECTION

A panel of judges appointed by the promoter will select the 2023 Penrite Brand Ambassadors. Selected applicants will be contacted prior to 1/2/2023. Notification will be made electronically or via the contact number provided. All reasonable steps to notify successful applicants of the results will be taken by the Promoter. The content on your profile page will be generated from your supplied Facebook Profile.

Content that we would encourage our Brand Ambassadors to post include; news, photos & videos of pre-event, during event and/or after event activities.

It is expected that at all times Brand Ambassadors are responsible to keep their Facebook profile up to date and include only relevant images, videos & news. ### **GENERAL**
